

- For books that are on an ASU campus, ask Facilities Management to pick them up and deliver them to us. To accomplish this, your department assistant can complete and submit a <u>FACMAN service request</u> on an on-line form. Facilities will schedule a pickup date with the office assistant. Advise the office assistant to provide your name and department to the FACMAN representative who picks up the books.
- **OR** bring your books to *our office*. We have 2 dollies for your use. Parking is readily available by the building with 3 ramps into the building and 2 elevators to the 2nd floor.

Tovrea Castle Tour — October 13, 2022

You have likely driven by the Tovrea Castle many times, probably wondering, why, who, when.

Tours are only available through a lottery ticket purchase and ASURA has been fortunate to purchase a tour with a maximum of 12 participants once a year. We then have our own lottery for individuals who express an interest in attending. Twelve names are drawn for a specified tour date.

On October 13, 2022 the ASURA tour group met at the Castle greeted by our tour director. Tours are held rain or shine and we were lucky to be in the shine category. We waited for all attendees to gather either in the gift shop or the adjacent outside waiting area where information about the Castle history is posted.



The gift shop is really a treasure and has many southwest and handmade items to tempt you. (Twice, coming and going)!

The tour group climbed aboard the shuttle and toured the grounds and outbuildings, stopping at points of interest. The 44 acres of desert cacti and natural Sonoran desert make a beautiful backdrop for the Castle on the hill. All of the trails are lined with river rock painted white making a dramatic picture. These rocks were collected from the Salt River and are one of the most eye-catching features of the gardens. Next the tour group entered the Castle where we were asked to put on booties over our shoes to protect the beautiful flooring. We learned about the history of the various owners, reconstruction, and maintenance of the property. The many rooms are furnished with original furniture and décor all with stories to tell.

The Castle is a fascinating historical structure Owned by the City of Phoenix but maintained and managed by the Tovrea Carraro Society, which are all volunteers. It is an Arizona Centennial Legacy Project and on the National Register of Historic Places. You are encouraged to sign up for the next ASURA Castle Lottery (TBA), it's quite amazing.

Retiree Help: Life Care Planning

The goal of Life Care Planning is to promote and maintain the good health, safety, well-being, and quality of life of elders and their families. Such planning is an important task for all of us, whether young or old, healthy or facing challenges. None of us knows what life has in store, so taking steps to tell our loved ones of our wishes can make all the difference on our end of life care.

Talking with others about your wishes

You should consider the people that you can begin your life care planning conversations with. Your medical care is about you - start the conversations with those who can help you consider what medical treatments you may or may not want if you become incapacitated, or as you approach the end of your life.

- Your health care agent (the person you select to make health care decisions for you)
- Your spouse, children, other relatives, and close friends
- Your doctor, clergyperson and others

Life care planning documents

• Health care power of attorney

This form allows you to select a person to make future medical decisions for you if you become too ill to communicate or cannot make those decisions for yourself.

- Living will This form allows you to list out the type of medical treatments you do or do not want for your end-of-life care. It should go with your health care power of attorney form so your agent knows your wishes.
- Mental health care power of attorney This form allows you to select a person to make future mental health care decisions for you in case you become incapable of making those decisions for yourself.
- **Prehospital medical care directives (do not resuscitate)** This form needs to be on orange paper and should be signed by you and your doctor. It informs emergency medical technicians (EMTs) or first responders not to resuscitate you. Sometimes this is called a DNR Do Not Resuscitate. Please note this is valid prior to going to a hospital. If admitted to a hospital they may require you to fill out another form for their hospital.
- **Registration agreement (optional)** If you would like to register your documents with the Arizona Health Care Directives Registry, you MUST fill out this form and submit it with your documents.

Note: The Life Care Planning documents can be filled out and submitted without consulting a lawyer but you may find it helpful to talk with an Elder Law / Life Care Planning lawyer for advice.
