

PRESIDENT'S REPORT

The ASURA seeks to further the welfare of retirees, by advocating at the university, legislature, retirement systems, and in the healthcare arena. ASURA also promotes educational, service, and social activities to enrich the lives of our members and the university community. During 2007-08, ASURA was active in each of these areas and completes the year as a stronger and more vibrant organization. Our successes were due to the efforts of the Board and other dedicated members who made significant contribution to the organization. I have attempted to review a few of the highlights from this year and to recognize some of the outstanding contributions. No doubt this list is incomplete as many people made contributions to make this year a success.

Homecoming was the biggest and best homecoming event that even old timers could recall. ASURA again sponsored a booth and greeted the crowds, old friends, and potential new members. ASURA Web Site & Technology Connie McNeill



In the Fall of 2007, the ASURA board recognized a need for improved planning, coordination and oversight of the use of technology to benefit the ASURA. At the request and suggestion of several Board members, Connie McNeill, who joined the ASURA Board in Fall 2007, volunteered to take on this responsibility.

ASURA Web Site: Bob Beeman created and for several years maintained the ASURA Web site. When Connie volunteered, he graciously and gratefully surrendered this lead responsibility. He has volunteered to help Connie maintain the new site.

In early March, 2008, a new ASURA Web site "went live". The address (URL) is http://asura.asu.edu. The new Web site follows ASU's standards on appearance and logo usage, and displays the new ASURA logo that was produced by Public Affairs staff, courtesy of Wilma Mathews. The Web site is housed at no cost to the ASURA on a server provided through ASU's Web hosting services. Services available will allow us to use the new site in a much more active and interactive way than was possible with the prior site, which was housed on an Arizona State Public Information Network (ASPIN) server.

The new Web site has already been used to provide easy access to information about upcoming events, including registration forms when these are needed.

Plans for improving the way the Web site supports the ASURA include:

- Implementing tools that will permit Board members and others authorized to easily create and edit content on the site, so that we will not be dependent on a single person for this.
- Providing for prospective and current ASURA members to apply for membership and to maintain their personal records via a Web screen. This project will take advantage of work that Dave Scheatzle has been doing to clean up the membership database and implement it in MS Access.
- Providing blog services and the ability for members (and possibly others) to comment publicly on articles that are published on the ASURA Web.

- Providing space and content restricted to members of ASURA subgroups. Example uses:
 - Provide documentation on procedures and dates that are important to ASURA officers and staff;
 - Provide a place for committee members to share planning materials, procedures documentation and so forth.

ASURA E-mail Lists (Listservs):

Dave Scheatzle has worked diligently for several years to support use of a Listserv mailing list of the ASURA membership – those who have provided e-mail addresses. The Listserv is hosted by ASU at http://lists.asu.edu and is named ASURET. It currently has 561 subscribers.

In February, Dave was able to pass responsibility for the Listserv on to Lois Lehman, who has volunteered to help with various technology support needs. Dave and Connie provide backup to Lois as needed.

Connie and Lois modified procedures for using the Listserv so that Board members and other authorized personnel can send out messages without going through someone else. Connie documented the procedures, and Lois trained Mary Stevens to use them, and Mary has successfully sent out messages about upcoming activities sponsored by the ASURA.

Plans for improving the way Listservs support the ASURA include:

 Implementing an additional Board Members Listserv, so that officers need not each

- individually maintain a distribution list for mailings to Board members and support staff.
- Building an interface between the membership database and the membership Listserv, so that these will be "in sync" and not have to be maintained separately.

ASURA Office Technology: The ASURA office has had three computers that were provided as "hand-me-downs" by Public Affairs at the time of occupying the new offices in the Community Services Building. These computers – one in the business manager's office, one at the reception desk, and one in the work room – needed to be replaced in order to create a more attractive work environment for volunteers and to meet current standards of performance and security, and to accommodate plans for increased use of technology.

During February of 2008, the three computers were replaced. In addition, the scanner attached to the work room computer was replaced. The scanner can be used to digitize printed materials and photographs for use in various publications and projects.

The new computers are Dell Inspiron 530s with Core 2 Q6600 Quad-Core 2.4 GHz Processor and 20" widescreen digital flat panel displays, 3GB memory, 320GB hard drives and 16X DVD +/-RW drive. They are running the Vista Home Premium operating system along with Microsoft Office 2007 Professional. The new scanner is a Canon CS8800F flatbed scanner. This equipment should support office needs for at least 3-4 years.

Plans for improving the way office technology supports the ASURA include:

- Showing officers and staff how to use existing tools and tools that will be implemented – includes documentation and training.
- Updating the membership application and renewal forms for better communication between members and potential members and committee chairs, etc. Mary Stevens is chairing a committee to work on this.
- Generating membership renewal notices from the membership database, to simplify the task of requesting renewals and to make the process more reliable.
- Creating easy-to-use inquiries and reports from the membership database. Dave Scheatzle is working on an MS Access project that will meet many of these needs.
- Possibly obtaining a projector that can be used to facilitate Board meetings and presentations that Board members make or sponsor – to be used in conjunction with a laptop computer. This would require Board discussion and approval.
- Helping the business manager create a bookkeeping system using Quicken. Working with her to interface these books with the membership database, to reconcile records in it with accounts held at the Foundation and, if needed, with bank-held checking and Visa accounts. Helping her set up financial reports needed by the Board using Quicken.

• Putting the office printer on the Ethernet network. Currently it is attached to the computer in the business manager's office, and this mean that computer has to be on for anyone to print.

Adopt-A-Family Program Joan Leard



Two families were adopted for this school year. One family of seven from the Tempe Elementary School District #3 and one family of three from ASU. The ASU mother is a Junior working on an undergraduate degree in special education and works at ASU in the Adult Re-entry Program office. The Tempe school mother attends South Mountain Community College and works. The program completes sixteen years partnering with TESD #3 and four years with the Scholarship Office at ASU.

At the time the Temple family was chosen by the school social worker they were homeless. This worker was able to find them a house to rent and we helped by donating \$200 for their first months rent. We also supplied clothing and food at Thanksgiving time. For the December

holiday we provided clothes, toys and food. The children have written individual notes of appreciation for their gifts on each occasion.

The ASU family consists of a mother and two children. In the Fall we supplied them with ASU apparel at their request and food for their Thanksgiving holiday. In December we gave them toys, household items and food. Thank you notes were received after donations were made.

The funds used for these purchases came from ASURA member donations and the ASURA treasury. With help from the members we will give these two families Spring clothing items. Please continue to donate so we may keep this outreach program going for many more years.

Arizona State Retirement System

Since the last annual ASURA report, the Arizona State Retirement System has won prestigious awards, managed its investments prudently in what became a challenging economy, and worked to keep its fund sound and its service efficient.

In 2007 the ASRS received a national award for meeting professional standards for plan design and administration and another for excellence in financial reporting. The ASRS also was rated a "Top Performer" in a recent nationwide study of pension plans by the Pew Charitable Trust.

For the fiscal year ending on June 30, 2007, the ASRS reported earnings of 17.8%, well over the 9.8% for 2005-06 and the 8.5% for 2004-05--a welcome rebound from the negative earnings of 2000-02 and the 2.4% return in 2002-03. The market value of ASRS assets rose from \$24.4 billion on June 30, 2006, to \$28.5 billion on June 30, 2007. However, by the fourth quarter of 2007 several factors--notably the "sub-prime" mortgage crisis and rising oil prices-produced a serious economic downturn. By the end of January 2008, the market value of ASRS assets had fallen, with the decline of the stock market, to \$26.5 billion. The ASRS's investment consultant, Mr. Terry Dennison, predicts that the downturn will last into the fall of 2009. Fortunately the ASRS has not invested in vehicles based directly on "sub-prime" mortgage debts. At the February 2008 Board of Trustees meeting, Mr. Dennison advised against undue concern and praised the ASRS for its balanced and conservative investment policy.

Because of the increased earnings reported for the fiscal year ending June 30, 2007, the ASRS was able to announce a reduction in the contribution rate for active employees and their employers from 9.6% to 9.45% for the fiscal year beginning on July 1, 2008

The Permanent Benefit Increase (PBI) which retired ASRS members had come to expect each July 1st was not available

in 2007-08 and will not be available in 2008-09. Arizona Revised Statute 38-367 dictates that the PBI be paid when the actuarially determined return on ASRS investments exceeds 8% during the preceding ten years. Because the negative and low returns of 2000-2003 are included in this span, the benchmark has not been surpassed. The current suspension of the PBI does not affect PBIs which were granted in the past. Retirees will not see any decreases in their monthly pension.

The funding ratio for the ASRS total fund was last determined actuarially on June 30, 2007, and is 83.7%, down from the previous year's 85.3%. ASRS Director Paul Matson has attributed the declining ratio over the past several years to the impact of the poor investment returns in 2000-03, to retiree benefit increases legislated in 2001, and to the very low employer/employee contribution rates in the 1990s. The funding ratio states the relation between the amount of money the ASRS has and expects to take in over a prospective thirty-year period and the amount it expects to pay out in benefits. ASRS Board of Trustees member Dr. Keith Meredith has said that the "healthy range" for funding ratios is between 80 and 120%, but of course full funding is the goal of any retirement plan.

ASRS efforts to maintain the soundness of its fund include a revision of its categories of investment and various legislative proposals for changes in the way its benefit program operates. In April 2007 ASRS policy allocated 6% of its assets to real estate (including realestate investment trusts), 26% to U.S. fixed-income securities (e.g. bonds), 53% to U.S. equities (stocks), and 15% to international equities. Now the policy allocation remains the same for

real estate and U.S. fixed income securities, while U.S. equity has been decreased to 45%, international equity has been raised to 18%, and 5% has been allocated to a new category, private equities (typically venture capital companies not traded on the public stock markets). Actual investment in real estate has reached about 2%, and implementation of the private equity category is just getting under way. Consultant Terry Dennison applauds the ASRS's expansion of international equities and foresees further expansion of that category by large investors generally in the near future. He also praises the ASRS cautious addition of private equities.

For the recent ASRS legislative proposals please see the Legislative Liaison Council report. In the area of improvements to ASRS service operations perhaps the most important to retirees is the completion of a computerization of its service operations so that office communications are "paperless." Members' records may be summoned up within seconds. The time in which survivor benefits can be initiated has been vastly reduced and has been eliminated in the case of survivors of members with joint-and-survivor annuities if the survivor's name and Social Security number are on record with the ASRS (for more on this, see the Winter 2008 issue of Prime Times). Also, by late May ASRS retirees will be able to log on the ASRS website and view their own annuity accounts.

ASRS information is available at its website, www.azasrs.gov. This report is based on that information, attendance at meetings of the ASRS Board of Trustees, and contacts with the ASRS Director and staff.

Education: Annual Retirees Day Sue Blumer



The fifteenth annual Retirees Day held on February 16, 2006 was a successful despite many unexpected trials and tribulations during the year, including the resignation of our long-time Chair, Joe Wilkinson and the devastating Memorial Union fire on the Tempe campus. Wonderful people came together and made a great day at the ASU Polytechnic campus possible. In spit of the distance and the unfamiliarity of many with that campus, the attendance of 100 showed that our members enjoy and support this activity.

We would like to thank all of the many people who helped, including ASURA President Doug Johnson, Activities Committee Co-chairs and Board members Mary Stevens and Val Peterson and the volunteer office staff, Education Committee members, the ASU Polytechnic staff members, ASURA Board members, and the excellent presenters and luncheon speaker. They all contributed to planning and carrying out the many details and task necessary for such a successful day. The ASU Polytechnic administration and staff were most welcoming and worked hard to help us, especially Vinette Williams, Director of Public Affairs, her assistant Carla Wales, Dawn Stark, Coordinator of Facilities and Operations, and Daun York, Catering Manager. Their positive attitude helped us to adapt to new spaces and conditions—and they and even put up the many signs that blazed a path to the Memorial Union facility. Dawn Stark and her helpers did quick-changing magic with the partitions in the Cooley ballroom. Daun York provided a tasty luncheon and snacks in the same spaces that were used for presentations, a daunting task indeed.

After a time of greeting friends over coffee and scones, Doug Johnson, ASURA President commenced the program with greetings and announcements. Dean David Schwalm, Dean of the ASU Polytechnic School of Applied Arts and Sciences, welcomed the audience to the campus and provided an interesting history and status report on the campus, its dramatic growth and dynamic programs. Mary Stevens gave further announcements and directions.

The six hour-long educational sessions provided something new and different as well as some of the excellent past topics and speakers. During the first hour, Los Valdes explained and demonstrated some of the principles of chi gong in *Improve Your Well Being with Chi Gong*, a 2000 year-old series of body movements and breathing exercises that are designed to calm the spirit and mind, strengthen the body, reduce stress, and improve balance and posture. He had participants taking part in the exercises for a stimulating experience.

Bruce Merrill, Professor Emeritus and Director of Media Research, Cronkite School of Journalism and Mass Communication, in a fascinating and timely talk *Not Politics as Usual*, discussed the first really open election since the 1950s and how people all over the world are excited about it. He talked about candidates' style, the influence of the media and large corporations, the rise of independents in America, the trend toward mass participation, and changing demographic trends.

Milton Sommerfeld, Professor, School of Life Science, presented a very interesting presentation on *Algae: One Solution to the Energy Problem?* with various audio-visuals. He described various potential uses of algae for energy production and other uses.

During the second hour, Jane Conrow, Librarian Emeritus, displayed her beautiful Afghan hound in a presentation on Caring and Sharing: Companion and Therapy Pets. Jane explained and demonstrated how therapy pets can make a positive difference in the lives of those in hospice care, nursing homes, assisted living centers and other similar situations. She explained that the animals love the attention and visiting their special friends who cannot have their own pets, what is involved in being a social pet therapy volunteer, and how to tell whether your own pet is suited for this role. She also showed a video.

Randall Cerveny, President's Professor, School of Geographical Sciences and Director of ASU Office of Climatology, made a presentation about *Weather Oddities*, everyone's familiar everyday topic. Professor Cerveny showed how weird and wonderful the weather really is, and he has the scientific evidence to back up the claims. He maintains international records on weather occurrences as well, and the reality truly surpasses any fiction that one usually conceives. He also showed polished audio-visuals.

Helle Brand of the Banner Alzheimer's Research Institute presented Alzheimer's Disease—Current Research, Clinical Studies and Programs for the Needs of Caregivers, a comprehensive discussion on the current state of knowledge about this common concern. She talked about preventive measures, diagnosis, current treatments, research for future advances in treatments, and other pertinent topics. Helle distributed helpful materials as well. She emphasized that the person with this disease is still the same person in essence and deserves that consideration. She also discussed the options and needs of caregivers.

During the interim when the rooms were being rearranged for the luncheon, Vinette Williams showed a slide presentation on the Polytechnic campus. After the meal, our speaker Dennis Burke, Governor Janet Napolitano's Chief of Staff, presented an excellent talk on the current state of affairs in Arizona. He was introduced by Mary Stevens with an impressive recital of his many past positions and accomplishments. Dennis explained in comprehensible language the problems and opportunities facing the State of Arizona today, displaying his extensive knowledge and analysis of the current difficult budget situation and other political issues. After his talk, Dennis opened the floor to question, and the responses from the audience showed how closely they were paying attention. The question-and-answer period went on for a fairly extended period, and he was very interested in and responsive to the questions asked. Our thanks goes to Jeanine L'Ecuyer of the Governor's office and Mary Stevens for help in obtaining this speaker.

After such a successful Retirees Day, ASURA members are invited to become involved in the planning for next year's event by serving on the Education Committee, by suggesting presenters and speakers, identifying topics for presentation and by putting the event on their calendars.

Health & Dental Insurance Committee Richard Murra



Health insurance for policy year 2007 didn't present many problems since the plans offered remained relatively unchanged. The high and low option plans introduced by United Care (PacificCare) while significant were apparently accepted as being necessary due to increases in prescription and medical care cost.

The most significant change was granting the ability to return to the ADOA plans for those retirees that had left the ADOA plan for either medical or dental plan, but retained membership in the other. So long as the member remained an ADOA member of either the medical or dental plan, the member regained the right to return to the ADOA system for both plans.

Retirees, for the most part, rejected resigning from State supported plans in order to join any of the Medicare Part D

plans offered by most of the commercial market. The assurance of stability, subsidy granted and breadth of coverage provided sufficient incentives to remain within the State supported systems. We hope that plans and premiums for calendar year 2009 remain as favorable.

Legislative Liaison Council Jerry Aronson



The Legislative Liaison Council (LLC) continues to monitor legislative activities impacting retirees and active (i.e., preretirement) employees. We exercise public responsibility also by supporting ASU in its roles as an employer and an educational and research institution. The LLC is chaired currently by Jerry Aronson who utilizes the extensive experience of Alan Johnson and Bob Mings. Johnson also serves as Chair Pro Tem when Aronson is absent due to traveling, etc. In carrying out its mission, LLC interacts on various levels with the ASU administration, the ASU Alumni Association(and its Sun Devil Advocates Network), the Tri-University Retirees Coalition, the Arizona Legislature(through attendance and/or advocacy at committee hearings and email, telephone or face-to-face communication), the Coalition of

Arizona State Retirees Associations and the Arizona State Retirement System(ASRS).

During the 2007-2008 year, the Council interacted with other groups sharing common interests. This past November, Aronson and Mings attended the annual gathering of the Coalition of Arizona State Retiree Associations. The Coalition is concerned with the practice of some retirees returning to work without paying into the ASRS Fund and displacing new hires who would pay. Also there is concern with the 10-year averaging method of gains and losses used by ASRS to calculate Fund surpluses that would support Permanent Benefit Increases (PBIs). Coalition members believe a 5-year method would increase the frequency of PBIs, but ASRS has statutory authority in this matter and is not likely to change methods. PBI-starved retirees should not expect any legislative remedy as benefit increases (which are not COLAs) depend entirely on domestic and global investment markets which, at present, are not showing favorable performance. We participated also in ASU Day at the Capitol on February 18. The Alumni sponsors have changed the format for the event, electing not to arrange meetings between volunteers and legislators. For this reason LLC did not recruit attendees although the Alumni Association did invite three of our members (Aronson, Johnson & Mings). We are told that the reason for not having small groups meet with individual legislators is that, in past events, some advocates(not any of ASURA's volunteers) advanced personal agendas rather than adhering to the Alumni Association briefings in support of ASU's budget requests. Thus, at this event, we now have little opportunity to interact with members of the legislature, although the three of us

in attendance did chat briefly with Senator Meg Burton Cahill (D) District 17. The Tri-University Coalition Meeting, usually held in Tempe in February has been postponed until a Fall date yet to be determined.

During the Second Regular Session of the 48th Legislature we have been watching the progress of specific proposals that are of interest to us. During this current session there is no Graded Multiplier Equity Bill. This initiative failed on three prior attempts and proponents have decided to wait for a more opportune time when the economic outlook is improved. Legislative proposals supported by ASRS that would, over the long term, strengthen the Investment Fund (and lower contribution rates) have met with only limited success.

HB2062 proposed a number of changes in the definition of "normal retirement". The 80 point rule would increase to 85 for new hires (on or after July1, 2009) and a 5-year compensation average would replace the current 3-year average. In addition, terminating members would be limited to a 25% withdrawal of employer contributions. Still making its way through the legislative process, the 85 point and withdrawal provisions have been removed from the bill.


HB2127 provides an ASRS exemption from State unclaimed property procedures. Monies that currently flow into the State Treasury would remain in the ASRS Fund.

At present, this bill appears headed for passage. ASURA supports HB2127.

A legislative proposal that would allow certain substitute teachers to opt out of ASRS participation has been killed as have proposals that would have extended certain rights to unmarried, domestic partners.

Passed by both Houses with bipartisan support and signed into law by the Governor, HB2705 will require ASRS to scrutinize its investments to determine if any of them are in commercial enterprises having business operations in Sudan. The legislation sets forth circumstances in which ASRS would be required to undertake divestment. Although this new law has some potential for weakening the Investment Fund, any small investment loss must be weighed against the social consequences of inaction.

Membership Report Elmer Gooding


