I. CALL TO ORDER

President David Schwalm called the meeting to order at 10 am.

II. INTRODUCTIONS AND WELCOME TO GUESTS

President David Schwalm welcomed the guest.

III. ADOPTION OF TODAY'S AGENDA

No changes to the agenda were requested.

IV. REVIEW AND APPROVAL OF THE MINUTES OF SEPTEMBER 14, 2011 BOARD MEETING

The minutes of the September 14, 2011 Board meeting were approved with minor amendments.

V. FINANCIAL REPORT / TREASURER'S REPORT - CAROLYN MINNER, BILL MOOR

Bill Moor presented the ASURA Budget for FY 2012. Bill noted he had transferred \$4562 to "Golf Luncheon" in the Operations budget from "Golf Luncheon" in the Special Projects budget. He also pointed out that he had added \$400 to the Operations expenses budget (Other Operations Costs) to cover Retirees Day lunch subsidies for guest speakers.

The Board approved a proposal to add \$240 to budget category "Events-all costs except advertising" under "ASURA Operations-Expenses" to cover refreshments for the ASURA seminars.

Acceptance of the budget as revised was moved by Bill Moor, seconded by Wilma Mathews, and approved.

Abigail Polito, ASU Legislative Liaison in the Office of Public Affairs indicated she had sent President Schwalm a link to a website reporting bills passed by the Legislature. ABBY described a possible plan circulating in the Arizona Legislature that would split off the ASU West campus from ASU as a stand-alone state college. She pointed out that, if the plan were approved, all programs and faculty at West would revert to ASU. She asked that the ASURA consider supporting ASU's opposition to this plan when it is introduced in committee in the State Legislature. ABBY also asked that the ASURA consider having a table at the Capitol downtown on ASU Day on February 11, 2012.

- special projects, and luncheons. Barb Eschbach agreed to convene a meeting.
- **B.** Wilma Mathews led the discussion of the advisability of preparing a brochure describing ASURA activities. A consensus emerged that there was a need for upgrading ASURA publicity materials for distribution at such events as ASU Day and recruitment of new members. Wilma offered to ask one of her students to develop a brochure for ASURA as an extracredit project. President Schwalm and Connie McNeill agreed to develop content for the brochure.

Arizona State University's West campus benefits from being part of ASU in the following ways:

• A Strong ASU Brand

Higher education is a crowded field with about 4,500 post-secondary institutions. Of that number, the vast majority are unknown outside their immediate vicinity and a relative few have reputations for academic and research excellence. ASU has a strong brand -- within Arizona as one of the state's two flagship universities and across the nation and throughout the world as a top university. One major ranking rates ASU as a top 50 American university, a second as one of the top 150 universities in the nation and a third as one of the top 100 universities in the world. It is this strong brand that draws students and top faculty to ASU West.

New Facilities

To accommodate the growth of student enrollment at West, ASU is building major new facilities:

A new residence hall will double the current number of on-campus beds for resident students. The 365-bed, 93,000 square-foot residence hall will feature 109 one- and two-bedroom suite-style units for two or four residents. Amenities include a social lounge, gaming lounge, study rooms, a community kitchen for programming use, laundry facilities, a business center and an interior landscaped courtyard.

The \$14.3-million residence hall will be built and owned by American Campus Communities, with whom ASU worked to establish the successful Barrett Honors College and Vista Del Sol projects on the Tempe campus.

Among the amenities in a new 37,000 square-foot dining facility will be open and private dining areas, late-night dining options, market-style servery areas and retail space.

The total project cost for the dining facility, also to be built by American Campus Communities, is \$9.5 million. ARAMARK, the dining service provider, will contribute to the project.

No state dollars or tuition revenues are being used to fund the residence hall or dining facility.

Augmented Academic Programs

- o West's core academic strengths are its New College of Interdisciplinary Arts and Sciences and the Mary Lou Fulton Teachers college. In addition, about 15% of the students at West take courses on other ASU campuses, including at:
 - The Carey School of Business,
 - The Fulton Schools of Engineering,
 - The Herberger Institute for Design and the Arts, and
 - The College of Nursing and Health Care Innovation.

Administrative Support:

ASU provides essentially all West's administrative and support offices, administrative and support services and administrators including:

o Human resources and benefits departments,

- Purchasing department, Admissions office, 0
- 0
- Financial aid office, 0
- Student advising,
- The library, 0
- Data processing for payroll, sponsored research, human resources and benefits,
- Construction management office, Security office and patrols, Fund raising office, 0

- Marketing staff.

If ASU Poly were to become an independent institution rather than part of ASU, the following would happen:

Loss of Brand

Higher education is a crowded field with about 4,500 post-secondary institutions. Of that number, the vast majority are unknown outside their immediate vicinity and a relative few have reputations for academic and research excellence. ASU has a strong brand -- within Arizona as one of the state's two flagship universities and across the nation and throughout the world as a top university. One major ranking rates ASU as a top 50 American university, a second as one of the top 150 universities in the nation and a third as one of the top 100 universities in the world. An independent Poly would start with no reputation or ranking and achieving high distinction is not easy. ASU, which was founded in 1885 and which became a research university in 1958, has achieved these rankings only within the last decade. It might take the Poly campus 25 to 50 years to recover the assets it lost in separating from ASU and even longer to achieve a strong brand.

• Loss of Academic Programs

- Because of the nature of Poly's academic configuration and several years of steep state budget cuts, an independent Poly would have far fewer academic programs. While Poly has general engineering and a specialized program in agri-business, independent of ASU Poly would have:
 - No "main stream" business programs,
 - No specialized engineering programs,
 - No fine arts,
 - No nursing
 - Limited arts and science courses.

• Greatly Diminished Research

- Poly has very limited research facilities. Most of the labs are in Tempe.
- Poly has no administrative research support, that is, no office to submit federal grants or oversee research as is required by federal law.
- Most of the high-level research present at Poly is actually university-wide research, is centered in Tempe and would be lost to Poly.

• Loss of Faculty

- Many of the top faculty at Poly would return to Tempe because they would no longer be able to do their research at Poly.
- Many faculty members would return to Tempe because they prefer the prestige of being on the faculty of a research university.
- New top-ranked faculty would be more difficult to recruit to a new school without an established research program and brand name.

Loss of Students

Students would be lost for a variety of reasons including:

- The diminished number of academic programs,
- o The loss of research,
- o The loss of top faculty,

- More than 20% of students at Poly take classes on other campuses and many would transfer to Tempe or ASU Downtown.
- o There are no varsity sports programs at Poly and few major student activities that are not university-wide. These are important considerations when students pick a college.
- Reputation is very important in recruiting students and accounts for the single largest part
 of the US News college rankings. Without a brand and high ranking, it would be difficult to
 attract the number of students currently attending Poly.

Loss of Administrative Structure and Increased Costs:

After years of centralization at ASU because of state budget cuts, Poly would lose and therefore have to replace essentially all its administrative and support offices, administrative and support services and administrators including:

- Human resources and benefits departments,
- o Purchasing department,
- Admissions office,
- Financial aid office,
- Student advising,
- o The library,
- o Data processing for payroll, sponsored research, human resources and benefits,
- o Construction management office,
- Security office and patrols,
- o Fund raising office,
- Marketing staff.

• Facilities and Capital Budget Issues

- o The size of ASU allows major capital investments to advance the Poly campus, which would be lost as a separate, smaller, less prestigious institution. The new academic village is an excellent example. The recreation center and dining hall both benefit financially from ASU's overall scale, which wouldn't be available to a small institution.
- In addition, paying for debt service incurred by ASU to improve the Poly campus, including \$103 million worth of new academic buildings, would have to be picked up by additional state appropriations, as ASU would not be paying for it.

ADOA Health Insurance Plans--Doug Johnson

Open Enrollment is rapidly approaching. During the coming open enrollment period, you will have an opportunity to make changes to your Arizona Department of Administration (ADOA) benefits for the 2012 Plan year beginning January 1, 2012. If you do not want to make changes to your current benefits, no action is required. The best news is that no rate increases are expected. This is a welcome relief and quite a contrast to the national trend of increases approaching 9%. Again this year, you can make changes using the online form or with the copy mailed to you with the enrollment guide. ADOA expects to mail Enrollment Guides by October 15, 2011.

Here are five questions for you to consider as you review the Enrollment Guide:

- 1. What is new this year? Make sure you understand changes in relevant plans.
- 2. What would the plan cost me? In addition to premiums, be sure to consider coinsurance, co-pays, and any deductibles that may apply. For this consider your recent history of health services. Remember, co-pays can add up quickly if you have re-occurring health needs.
- 3. Next, consider what would happen if you had a worst-case health scenario. Some plans are now offering an out-of-pocket maximum, which may limit your financial exposure.
- 4. If you are on maintenance medication for a chronic illness check for policies that may limit your total costs.
- 5. Consider participating in a health coach program. Working with dietary counselor or a wellness coach may improve your health limit your long-term costs. And, be sure that you get your flu shot.

Other things to consider before changing plans:

- 1. Verify your doctors are in network. Also consider your future medical needs.
- 2. List your prescriptions and price out your costs using formulary rates.
- 3. Verify your preferred hospitals or clinics are included in network.
- 4. If you are becoming 65, notify your plan one month in advance. Make sure you get registered for Medicare Parts A & B, but not C or D.
- 5. If you should decide to switch out of ADOA medical plans, consider retaining your ADOA dental plan so you will have the option of re=enrollment at a future open enrollment.
