It was pointed out that a donation of \$115, received and approved for the Adopt-A-Family Program in December, needed to be reflected in the budget. The correction will be reflected in next month's financial statement.

- University Club Liaison Jim Fordemwalt
 Jim reported that the University Club held a successful Christmas party and a
 High Tea. He reiterated that the University Club is interested in bidding
 future ASURA events.

• University Liaison – Barbara Shaw-Snyder or Abby Polito Regents rolling out tri-university legislative issues. Board is invited to attend the legislative day event on February 11 at the Capital.

Mike Bercovici, ASU quarterback, has won Pac12 Football Scholar-Athlete of the Year honors award. The award, established during the 2007-2008 academic year, honors collegiate student-athletes that are standouts both academically and in their sports discipline.

ASU ranked #3 all-time Most Academic All-American athletes in the Pac-12. Swim Coach Bob Bowman has been named the US Olympic Swim Coach. Olympic swimmer Michael Phelps trains and coaches under Coach Bowman and uses Plummer Pool as his training facility. This prestige has enhanced ASU's recruiting efforts for the Swim Program.

W. P. Carey (WPC) School of Business is offering a Full-time MBA program featuring an innovative Forward Focus curriculum to meet the rapid changes and new realities in business. In addition, WPC is offering the Forward Focus MBA scholarship, a full scholarship, to all accepted students entering the Fall 2016 program. Goals: bring in the best and brightest students to ASU and increase women participants. A WPC philanthropist is making this possible – the scholarship to all of those admitted for 2016 and the philanthropist is also making it possible to revise the MBA curriculum to make it more dynamic and relevant for the changing times in business.

SkySong is offering a program to women making less than \$1M per year. The cost of the program is \$250 for materials only. It's called SparXX 20 (https://entrepreneurship.asu.edu/sparXX)

The Starbucks program w/ASU has been expanded to include both the freshman and sophomore years for all fulltime and part-time Starbuck employees. Starbucks reimburses eligible students for the cost of obtaining bachelor degrees at ASU online.

ASU's white laser technology has been recognized as one of the top 100 scientific breakthroughs in 2015 by Popular Science magazine. Electrical engineering professor Cun-Zheng Ning and his team of graduate students cracked the problem.

Elleen Klein, President of ABOR, College Success Arizona, and ASU President Michael Crow are focused on higher education attainment goals for the State of Arizona. Other states have these, and Arizona can benefit from a state supported postsecondary attainment goal.

- Scholarship Committee Sue Blumer, Joy Sherman Sue reported that they are in the process of receiving applications for this next year's scholarship.
- Video History Project Dave Scheatzle
 Linda Van Scoy reported on behalf of Dave Scheatzle. The Video
 History Committee meets next week to prioritize a list of new potential

History Committee meets next week to prioritize a list of new potentia interviewees. Interviews will continue as new subjects are identified and appointments scheduled.

Almost 80 clips are now on the website to review.

Approximately 45 video clips have been added to the University Library Archives.

The Budget shows a line item of \$4600 for the Video History Project and a question was asked about the purpose of those funds. Linda noted that funds are used for transcripts and other items relevant to the interview process.

B. Events Committee and Subcommittee Reports

- Events Committee Coordination Barry McNeill No report
- Luncheons & Special Events Joyce Hartman Diaz Joyce reported that there were 43 attendees at the December Holiday Potluck and Bake Sale and a profit of \$164 was made from the bake sale.

Planning for the Spring luncheon is underway;

Jim Fordemwalt asked Joyce to plan the Annual Meeting scheduled for April 16 in the Memorial Union on the Tempe campus. Traditionally an afternoon meeting, there was discussion about moving the start time to 11:30 a.m. and adjusting the menu accordingly. Carolyn Minner volunteered to check the availability of the facility with the time change.

• Seminars – Jan Thompson

Jan reported that the Volunteer Fair was cancelled for lack of attendees.

The Sleep Seminar scheduled for January 28 is filled. There are 3 excellent presenters, Dr. Matthew Buman from ASU's School of Nutrition and Health Promotion, Dr. Megan Petrov from ASU's College of Nursing and Health Innovation, and Dr. Lois Krahn from the Sleep Disorders Center at Mayo Clinic. A waiting list has been started in the office.

Joyce Hartman Diaz is working on February seminar on the topic of Arizona Wills, Trusts, and Probate.

Bev Buddee reported that the March 17 seminar on Scams & Scammers & Financial Fraud will feature speakers from AARP and the Arizona Corporation.

Travel – John Brock
 John noted that registration for the tour of the ASU Downtown

Campus, scheduled for January 20 is underway. Hosted by Barbara Shaw-Snyder, this tour will talk about the programs and include a walk-through of the new Law building. Lunch at a downtown location will follow. It is suggested that participants take light rail downtown and avoid parking.

Two tours of the Tovrea Castle are scheduled for 8:30 AM and 11:00 AM on April 1. These tours have a capacity of only 13 people each, so they fill exceedingly fast. Reservations will be enabled on March 4. Office staff will be asked to carefully log the time of online and call-in reservations.

The Cuba trip in planned for March 5-17 through Grand Circle Travel. Reservations are being taken by Grand Circle Travel.

The Travel Committee is looking at a visit to the Wright House and wine tasting in the Verde Valley or Southeast AZ

C. Finance Committee – Barry Bruns

The November meeting of the Finance Committee found a significant reduction in the carry-forward balance. A review of the Operations Account shows that almost half of the annual expenses are the \$10,000 scholarship. In order for the Association to maintain its spending at a level to match its annual revenues, the Finance Committee recommends that ASURA discontinue the \$10,000 scholarship for Fiscal Year 2017 and all years thereafter, until such time as adequate cash reserves are available. Considerable discussion ensued about various alternative solutions to discontinuing the scholarship. Ideas tossed out:

- a reduced amount scholarship funded by Endowment income of approximately \$1,500 per year. Currently Endowment income is reinvested back into the fund.
- donations to the scholarship endowment fund. All monies received by ASURA that are designated for scholarships add to the principal of the Endowment Fund, minus any administrative fees.
- creating a new budget line item for scholarships, similar to the Adopt-A-Family program, which would be funded through specific donations made to the general operating fund;
- a fund-raising event like the golf tournament.

Sue Blumer was advised to continue with the current application process as the funds have been committed for the 2016 scholarship.

It was agreed that the ASURA books need to be closed for this year before further discussion about any commitment to scholarship can be entertained.

A motion was made to accept the Finance Committee recommendation with the substitution of "suspend" for "discontinue" in the wording. The revised recommendation reads: The Finance Committee recommends that ASURA suspend the \$10,000 scholarship for FY 2017 and all years thereafter, until such time as adequate cash reserves are available. Motion

was seconded and passed unanimously.

Book Collection – Mary Stevens
Bev Buddee reported for Mary that book sales netted \$611.98 in the
last quarter of 2015.

D. Government Liaison Council

ASRS General – Larry Carlson

Larry reported on an *Arizona Republic* article (Sunday, January 10, 2016) about the State budget that revealed that Governor Ducey and the State Legislature agreed to sweep \$100 million from the Health Insurance Trust Fund. Payments into the fund exceed the cost of health care coverage meaning that some of the monies paid by state and university employees end up in the general operating fund. The universities, as employers, pay 85% to 90% of their employees' health-care costs into this fund. The universities are critical of this approach as some tuition monies are used to fund the payments. This practice lends weight to the proposal in the ABOR 2016 Legislative Agenda: Enterprise Regulatory Reform Initiatives to "permit Arizona universities to move toward a more sustainable, competitive and cost-effective benefits program for their employees."

Legislature – Hal White and Jeri Meeks
 In his State-of-the-State speech on Monday, Governor Ducey spoke positively about the Universities.

The legislative session reconvened on Monday and legislative bills are now posted on the website. Jeri, Larry Carlson and Hal White have searched the bills for those of interest to ASU/ASURA. Two bills stand out:

HB 2072 – Firearms on university and college campuses. This bill amends 2 Arizona Statues (13-2911 and 12-3102) and allows an exception to registered students and faculty to carry guns on campus if they have a valid weapon permit and have registered with the institution's administration.

SB1031Voting on campus. This bill allows student organizations under the auspice of ABOR to set up voting centers for each campus during the early voting period and on Election Day. The voting centers will provide an appropriate ballot and allow voters to lawfully cast the ballot.

The ABOR 2016 legislative agenda calls for additional regulatory relief to allow the universities to become "more agile, more adaptable, and more entrepreneurial." This University Enterprise system would authorize the universities to issue commercial paper and obtain commercial lines of credit; permit the enterprise to develop independent benefit programs- healthcare, property/casualty/worker's compensation insurance, and retirement programs.

At the recent Legislative Advocacy Breakfast, President Crow talked about the new proposed state investment model asking the state to provide 50% of in-state or resident student tuition (currently calculated at 34%). These funds would total \$24M and would come from last year's revenues, which exceeded the forecast. The funding model – supporting resident students – is part of a larger plan to raise K-12 standards and promote Arizonans going to college and staying in state to grow the economy. Emphasizing this model, the first breakfast speaker was Rich Nickel from College Success Arizona.

Jeri reported that she will be attending a Conversation with President Crow tonight, an ASRS Board meeting on January 29, and the ASRS External Affairs committee meeting on February 12.

Jeri asked the Board for direction regarding support for the current ABOR budget request. The Board authorized Jeri to it supports the current ABOR budget request.

Jeri invited ASURA Board members to join her at the ASU at the Legislature Day.

- ASRS Joyce Hartman Diaz ASRS survey was recently sent out to the membership. Board members talked about problems encountered in filling out the survey; Joyce said she would relay this information to ASRS.

VII. UNFINISHED BUSINESS

- Invitation to ASRS to speak at a future Board meeting about ramifications to retirees if ASU moves from ASRS to an optional retirement program. Larry

Carlson volunteered to invite an ASRS representative to speak at the February Board meeting.

• Nominating Committee – Jo Madonna

Jo is setting up the nominating committee. The membership will need to vote on 5 potential new Board members. Two candidates from staff have been identified; 3 additional candidates need to be recruited. Ideally, the nominees will include both retired staff and faculty. Because John Brock and David Schwalm know 3 suggested retired faculty members, Jo asked them to approach these individuals to determine their willingness to serve a 3 year term on the Board. She asked that John and David let her know the outcome by the end of the week. Voting will begin in early February; successful candidates will be presented to the Board at the Annual Meeting in April.

VIII. NEW BUSINESS

• Volunteer Appreciation Luncheon With budget in mind, the Board discussed participants in the Volunteer Appreciation Luncheon – office staff, Committee Chairs, and Board Members. Motion was made to include all of the above groups in the luncheon. The motion was seconded. Vote results: 1 yea, 11 nays. Following further discussion, a motion was made to recognize all volunteers (office staff, committee chairs, and board members) during the Annual Meeting. Maximum budget should not exceed \$600. Motion was made, seconded, and passed unanimously.

Finance Committee Recommendation

The Finance Committee met to discuss the current financial health of ASURA. For Fiscal Year 2015, the Operations Account balance decreased from \$35,760 to \$25,548, a 30% decrease in just one year. As well, the Fiscal Year 2016 budget for the Operations Account shows a continuing significant decrease, down to a budgeted June 30, 2016 balance of only \$16,483, constituting more than a 50% decrease in the carry forward balance of the Operations Account in just two years. At this rate of decreasing balances, ASURA will soon be insolvent.

A review of the recurring annual expenses of the Operations Account shows that almost half of the annual expenses are the \$10,000 annual Scholarship award. In order for the Association to maintain its spending at a level to match its annual revenues, elimination of or a significant reduction in the annual scholarship award appears to be the only viable option. The other non-scholarship expenses are individually relatively small and are needed for ASURA to maintain its existence, such as Prime Times, Technology Services, office supplies/equipment and events.

Therefore, the Finance Committee recommends that ASURA discontinue the \$10,000 scholarship for Fiscal year 2017 and all years thereafter, until such time as adequate cash reserves are available.

It is noted that approximately \$1,500 annually would be likely available from the Scholarship Endowment earnings to fund a much smaller scholarship award. For the last several years, these earnings have been reinvested back into the endowment, but are available for the future to be spent annually and not reinvested.
