- Seminars Beverly Buddee, Trudy Perez Pursuant to discussion at the September Board of Directors meeting regarding the ASURA membership desire for more health care related information, the Seminar Committee decided to focus on a health related theme for the Spring 2017 seminars. Further, the seminar dates will be scheduled so as not to interfere with scheduled events at the Emeritus College. #### D. Government Liaison Council

• ASRS General – Larry Carlson Larry informed the Board that he recently met with Paul Matson, ASRS Executive Director.

# Legislature – Jeri Meeks Jeri informed the Board that she, Tara Roesler, and Larry Carlson had met with Steve Miller, Deputy Vice President of University Affairs. From that conversation, Tara reported the ASU components of the

From that conversation, Tara reported the ASU components of the tentative 2017 Arizona Board of Regents (ABOR) legislative agenda are:

- ➤ ASU will not be pursuing legislative changes regarding ASRS membership. ASU now offers employees ASRS or Optional Retirement Plans.
- ➤ Currently the annual cost to the University for each in-state, undergraduate student is \$15,000. The state only appropriates from the General Fund \$5,000 per student. The Arizona Board of Regents is proposing increasing the General Fund portion of the annual per student cost from the current 33% to 50% over the next three years. The economic impact of the legislation would be approximately \$80 million each year until in year three the total amount would be approximately \$245 million.
- ➤ Currently each campus of Arizona State University is separately appropriated. Arizona State University, with the approval of the Arizona Board of Regents, will be seeking an efficiency measure to consolidate the University's Budget into a single appropriation.
- Currently State of Arizona Employees including University Employees, working 20 hours per week or more are eligible for benefits. The Arizona Board of Regents in conjunction with the Universities will be seeking legislation to raise the benefit eligibility level up to 30 hours per week or more, consistent with the Federal Government Policy.
- Currently, Northern Arizona University is permitted to have its own Health Insurance Program outside of the Arizona Department of Administration and the Arizona State Retirement System. The Arizona Board of Regents and the Universities will be supporting Legislation to provide Arizona State University and the University of Arizona with the ability to have their own Health Insurance Programs or the Universities may join together for a single Tri-

#### University System Program.

- Other Legislation and issues of concern to the Universities that will be actively monitored include:
  - Any legislation that would allow guns on university campuses.
  - ➤ A Grand Canyon University (GCU) proposal for a Tax Exemption for Class 6 Property. Currently the Arizona public institutions pay a transaction privilege tax (only 1 of 6 states). A possible position for the Universities would be to have the University paid transaction privilege tax earmarked for Research. The tax currently brings in \$15M to \$30M for all three universities and ASU's portion is estimated to be \$13M.
  - Legislation, to support the University's Capital Improvement Budgets of \$200 per FTE student.
  - Arizona State University Center in Mesa on the ballot.
  - ➤ ASU has signed an agreement with Mayo to open a medical school next Fall. Class size will be limited

Jeri also noted that the Tri-University meeting will be held at the University Club on November 21.

#### E. Health Insurance Liaison Council

ADOA – Larry Carlson
 Larry reported that insurance offerings appear not to have changed over last year. No information on combination situations of Medicare/Non-Medicate families has come out.

#### • ASRS – Tara Roesler

Tara reported big changes this year as ASRS has expanded insurance plans available to non-Medicare eligible retirees. Two distinct types of benefit plans are being offered: CHOICE and NAVAGATE that allow members to choose the premiums and level of service that best suits their needs and where they live. She encouraged everyone to go to the upcoming open enrollment health care seminar.

#### F. Membership and Communications Committee – Subcommittee Reports

 No report. Jeri Meeks reported that Jo is seeking news items for the November E-Blast.

• Membership Update – Dave Schwalm Dave reported that membership is down about 8 members from last year's total at this time. He also reported that he had just finished a HR Retirement meeting. A large group of folks was present, and they seemed receptive to ASURA. Since many folks considering retiring opt for individual meetings with benefits personnel in lieu of the retirement meetings, Katie Aguilar agreed to take several issues of the current *Prime Times* and the new ASURA tri-fold brochure to have on hand in Human Resources for such instances.
