President's Message

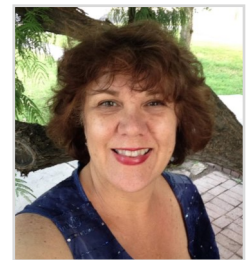

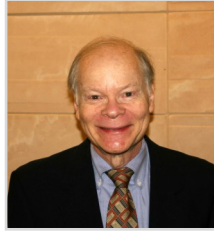
A Retiree's Eye on the Legislature

As fall rolls around the state legislators and lobbyists are gearing up for the Spring 2017 Legislative Session and the ASURA Legislative Liaison group points a curious eye toward ABOR's legislative agenda and the Capitol Report's Yellow Sheet for hints as to what this law-making session will bring.

This year our team includes Jeri Meeks, Tara Roesler and Larry Mankin. As always we will coordinate our efforts with ASURA Liaisons to the Arizona State Retirement System (ASRS) and Arizona Department of Administration (ADOA) – Tara Roesler and Larry Carlson respectively – for comprehensive legislative coverage.

ASURA was pleased to support ABOR's 2017 state funding plan focused on a public investment in Arizona resident students. This funding model resulted in a \$13.2 million budget increase ... \$3.0 million of which is dedicated to the School of Civic and Economic Thought and Leadership. With this new fiscal focus on in-state students and in joint cooperation with Governor Doug Ducey's **Achieve60AZ** initiative,

Arizona is primed for educational and economic growth.

We look forward to attending ... and reporting on ... the Tri-University meeting, ASRS Board and External Affairs meetings, Dr. Crow's ASU Alumni Legislative Advocacy Breakfast and meetings with University Liaisons. As we did last year, our team will be proactive in recruiting speakers for the ASURA Board meetings to keep our organization current on legislative issues.

State legislation affects all of us and we appreciate the support of our organization and members.

ASRS Open Enrollment for Healthcare Coverage

Open Enrollment for insurance benefits for calendar year 2017 begins on Monday, October 24, 2016 and will continue through Friday, November 11, 2016.

- Enrollment packets are scheduled to be mailed on October 10th.
- This will once again be a "passive enrollment". **If you are happy with your health and dental insurance coverage, you need not do anything.**
- ASURA will be holding a Health Insurance Seminar on October 20th at 10:00 am at the Tempe History Museum (809 E Southern Ave, Tempe, AZ 85282). Space is limited so please go to the ASURA web-

site to make your reservations or call the office 480-965-7668. If you are attending the ASURA Health Insurance Seminar, please bring the packet(s) you receive by mail with you.

NEW FOR 2017

- Online Health Insurance Application that is available through your **myASRS** account. The packets **WILL NOT** contain an Enrollment Form. If you do not have a **myASRS** account you can either go to <https://www.azars.gov/> and establish one ... or you can request an enrollment form from ASRS ... or you can obtain a form at the ASURA Health Insurance Seminar.
- **Medicare Plans:** Plan coverages remain the same but premiums are decreasing.

Plan Name	2017 Monthly Premium Retiree Only	% of Increase or Decrease Over 2016
Senior Supplement + PDP	\$332.00	-1.5%
Medicare Advantage HMO*	\$174.00	-10.3%

*As part of the Affordable Care Act of 2010, insurers are required to pay an insurer fee. The Centers for Medicare and Medicaid Services (CMS) did not increase plan funding in order to cover the fee. For the 2017 plan year there is a one-year waiver of the insurer fee; resulting in a lower premium for ASRS Medicare Advantage HMO Plan. ASRS expects the fee to be re-instated for 2018. In a typical year, the impact of the insurer fee on the cost of your health plan is about 3.0% of plan revenue.

- **Non-Medicare Plans:** Five new plan options have been added offering a broader range of lower-cost premium options with slightly reduced benefits. For details, please reference ***“Non-Medicare Eligible Retiree & LTD Medical Plans Comparison Chart”* and ***“3 Things About the Navigate Plan”*.

Video History Report - Fall 2016

As we begin our 2016-2017 interview season, most of our interview crew members have returned from their summer trips and have interviews scheduled for this fall.

To access these videos, visit the following web site: <https://repository.asu.edu/collections/199>. In the upper right hand corner, click on “sign in”. Use your ASURITE account and password to sign into this web site. If you do not use your ASURITE account and password, all of the available interviews will not be visible or viewable to you.

Currently, there are seven pages of names. To make the names alphabetical, there is a drop down box to the right titled “Sorted by most relevant.” Click on “Title”. Scroll down and click on the person’s name whose interview you want to view. A new page will open for that person. On the right side of the page, you will see that person’s interview file on the upper right. Click on ”Download.” The video should begin to play if you have the standard software for playing video.

New Video Team Member

We are honored to announce that Carl Cross is graciously volunteering his time and expertise by joining the ASURA Video History team.

Carl began his library career as a student assistant in Matthews Library in 1964. He was among those who watched Hayden Library take shape and worked there up until his retirement in August 2015.



For seven of those years he worked with Alfred Thomas to help create the University Archives collection. In 1989, he was asked to take on the task of cataloging the Arizona state and local documents collection that was only searchable via a KWIC-KWOC printout. This collection is now fully cataloged using a unique classification scheme developed by ASU and the Arizona State Library.

As electronic publications became popular, the ASU Digital Repository was created and Carl produced metadata for all the state documents harvested and made available via the internet. He also worked with the Morrison Institute for Public Policy to create an online archive of all their publications.

In the spring of 2015, he became the secretary of the Board of Directors for the Arizona Association of Manufactured Home Owners, a non-profit organization that works with a lobbyist to protect their rights through legislation. Carl is also the worship leader for his church and sings with the East Valley Chorale.

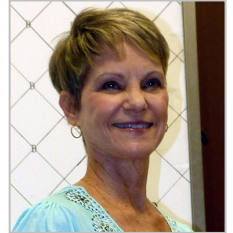

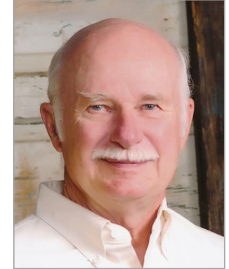
