I. CALL TO ORDER

President Meeks called the meeting to order at 10:00 a.m.

VI. Ex-Officio Reports

- ASU Alumni Association Rhonda McClintock No report.
- Emeritus College Liaison Don Nilsen
 President Meeks reported on behalf of Don Nilsen. On Thursday, February 8,
 ASU's Project Humanities held an event entitled "Dispelling the Myths:
 Religious Doctrines and Religious Dogma." The event was held at ASU's
 West Hall, and the discussion involved the following world views: Sikh
 Muslim, Jewish Mormon and Atheist (Secular Humanist). The event was

enlightening.

Additionally, the Emeritus College's February Short Talks Luncheon is held today at Friendship Village. Dirk Raat, ASU History Professor, will talk on the subject of "Lost Worlds of 1863: Relocation and Removal of American Indians in the Greater Southwest." Mark Reader, ASU Professor of Political Science, will talk on the subject of "Art in a Time of Disintegration: On the Survival of the Human Species." The Board was invited to attend the presentation.

- University Liaison –Stephanie Salazar
 Stephanie reported that the House has been busy; this is the last week they will be hearing bills. There are some bills to note.

HB2237 – Psychologists Licensure; Requirements: An applicant from a program that was accredited by the American Psychological Association, Office of Program Consultation, or the Psychological Clinical Science Accreditation system at the time of graduation.

SB1088 – Children; Veterans; Disabilities; Tuition Waivers: ABOR and community college districts are required to provide a tuition waiver to the child or dependent of a veteran whose disability rating is 30% or more, an AZ resident, and stationed in Arizona at the time of the injury. There are some additional stipulations. The tuition waiver will be reduced by the amount of any other federal aid scholarships or public grants.

HB2475 – Appropriation; Arizona National Guard; tuition: Appropriates \$1,446,000 from the GF in FY2019 to DEMA for tuition and fees for Arizona National Guard members.

SB1215 – WICHE: Continuation

The statutory life of the Western Interstate Commission for Higher Education (WICHE) is extended 8 years to July 1, 2026. Retroactive to July 1, 2018.

HB2481 – Foster Care Tuition Waiver: The ABOR and each community college district is required to provide a "tuition" (defined) waiver scholarship to an Arizona resident who was in foster care when the person was at least 13 years of age, was adopted from foster care and the adoption was finalized with the person was at least 13 years of age, or is currently in foster care and is at least 13 years of age, and who meets a list of other specified qualifications.

HB2280 – Universities, Lease-back Financing: The ABOR cannot enter a development agreement or execute a transaction for which a deed is transferred to the board and the board or university subsequently leased back to a private entity for commercial use, unless the property is used for

a primarily academic purpose, for student housing, or as authorized in section 15-1636. The Board cannot designate a new research park or increase the size of an existing research park without approval from the legislature. The Board will review all leases to make sure universities are compliant, and may not designate this authority.

Stephanie also noted that the budget request includes monies to bring state tuition funding closer to 50/50 for instate residents. President Crow will speak to tuition at the March ABOR meeting.

D. Government Liaison Council

• Legislature – Jeri Meeks

President Meeks reported that she had attended the Legislative Breakfast at which the 2018 legislative priorities were shared. The Capitol Times monitored the discussion, which was very general in nature. ASU Day at the Legislature is tomorrow (2/14). ASURA will be represented at the event.

There are a couple of bills of interest. SB1054 defines the process and criteria for employers who want to leave ASRS. This bill is moving through the Senate Rules and Finance committees.

HB2110 shifts governing responsibilities from ABOR to the "Governing Board of a University", giving universities the freedoms to negotiate retirement and healthcare programs among other things.

This bill didn't go anywhere in the house and has not been assigned to any Senate committees.

Vice President Roesler also brought up HB2034, which moves the role of "social security administrator" for Arizona from ASRS to a state agency designated by the Governor. There's some concern about the fact that the new ASRS Board doesn't seem to be very active in the legislative process and that this Board seems to be losing its

voice/influence in the government landscape. This bill has moved through the House and is now in the Senate.
