Good morning ASURA Board! Here are the active bills we are watching:

Voting:

HB2596 – **elections**; **revisions**; **mail-in**; **identification**; **tabulation**. This bill will require that ALL voting takes place in person on election day only! It was introduced by the Republicans and is gaining a lot of support! If it passes, it would be enacted in 2024, just in time for the Presidential election! There may, and that's a big "may" be provisions that a person qualifies for mail-in ballot but must prove reason to have such a provision granted.

SB1255 – **lieutenant governor; duties; ballot**. This bill establishes the office of the Lieutenant governor and defines the duties for that position. It has already passed in the Senate and was sent to the House on 3/3/2022.

Other voting bills I'm watching have not had any action since the end of January, some have had no action since they were introduced.

Universities

HB2276 - state law; violation; schools; universities. This is a revision to Revised Statutes and expands the legislators' abilities to call for an attorney general investigation for violations of state law, ordinance, regulation, order or other official action. Originally meant for investigations into city, county and town violations, this bill specifically adds the "Arizona Board of Regents or governing body, or the governing board of a community college district, school district or Charter." The House Majority and Minority caucuses proved this bill, with amendments, on Feb 22nd.

SB1082 – ASRS; lease-purchase agreements; contribution; prepayment. (Was ASRS; Employee contributions; prepayment) This bill has changed directions and now allows and ASRS employer to prepay the employer's required pension contributions (directly to ASRS) by borrowing or by entering into lease-purchase agreements for school buildings. This bill has passed the Senate and moved onto the House as of 2/24/22

SB1083 ASRS; modifications. This bill has a few concerning provisions, such as it removes statute relating to the ability of the ASRS board to make payment to another person in the case of incapacity of a retired member or contingent annuitant. It has passed from the Senate to the House. I've asked Dick Jabob his thoughts and if he's received any feedback from ASRS.

SB1145 – ABOR Optional Retirement programs. Revises ARS 15-1628. The purpose of this bill is to allow ABOR to set up an ORP for employees and guarantee that ABOR matching funds, if not transferred to an ORP after 5 years of service, are "forfeited to the institution" instead of going to the state. This bill has not moved since 1/12/22.

SB1123 - **disruption**; **educational institution**; **concealed weapon**. The purpose of this bill is to prohibit "the governing board of any university, college or community college from prohibiting the possession of a concealed weapon by a concealed weapon permit holder, or the lawful transportation or storage of a firearm." This bill has not had any action since 1/24/22.

HB2447 – **firearms; universities; community colleges; campus**. This bill allows faculty members and registered students to carry or possess firearms on the property of public universities and community colleges, provided they comply with specific requirements. This bill was on the Consent Calendar on 2/14/22 but did not move forward due to an objection.

NOTE: I/Jeri have entered an "against" position in the AZLEG.gov system for both SB1123 and HB2447.

HB2231 – universities; water rights adjudication. This bill reinstates a requirement that the state university offer pro bono assistance to claimants in the general stream [water rights] adjudications who are small land owner without legal counsel. This House bill has moved on to the Senate.

Health/Vulnerable Adult

SB1162 – opioid prescriptions; intractable pain; exceptions. This bill exempts patients with perioperative surgical pain, intractable pain or chronic intractable pain from statutory opioid prescription dosage restrictions. This bill has passed the Senate and is now being considered by the House.


HB2049 – **fingerprint requirements; care facilities.** This bill directs volunteers or contractors of residential care institutions, nursing care institutions or home health agencies providing specified services to have a valid fingerprint clearance card or apply for a fingerprint clearance card withing 20 working days. This bill is through the House and in the Senate.

The Crossover date – 100 days after the Legislative session starts - is approaching quickly so if bills don't move forward in their initiating arena (House or Senate) it is unlikely they will move forward this legislative session. But there are over a hundred strike-all bills hanging out there can help legislators work around this rule. Stay tuned!

Comments (61)

- 1. I believe more guns lead to more gun violence. I see that countries with lower guns per capita have less gun violence. There is no need for guns on a college campus.
- 2. Guns have no place in an educational environment. Students and faculty should feel enabled to have robust discussions and share varying perspectives without fear of harm. Students living on campus should feel safe in their residence halls that they won't be collateral damage from another students misfire or intentional fire. Campus police should not have to enter a situation not knowing who the "good guy" is vs the "bad guy" crime is significantly lower on college campuses than elsewhere. The proposed legislation is unnecessary and will be harmful. I strongly oppose the pending legislative proposal.
- 3. The pending bill in the Arizona Legislature, if made into law, would increase the risk of campus shootings. It would also greatly impede the teaching function of the universities. And it would make it more difficult to attract talented new hires to the faculty.
- 4. MORE guns is not what is needed on-campus or ANYWHERE ELSE for that matter. Please do NOT allow concealed weapons to be carried on ANY University, College, or School in the state of Arizona.
- 5. Guns serve no useful purpose on any campus, especially one with such a large number of people thereon. I agree with what I think was an early comment by President Crow: 'you take a gun somewhere to use it.'
- 6. Guns have no place on a campus
- 7. I would not teach at a university where concealed weapons are allowed.
- 8. There is no need for anyone: student, faculty, and/or staff to bring a weapon on campus. That's why there are campus police.

- 9. There are many students who already carry on campus, why do we want to make more. Raging hormones and firearms are exactly what is needed on the college campus! What a crock initiated by people who live in fear.
- 10. We need to remember the loss of three innocent professors and the assailant @ one of our triuniversities U of A in 2002. Weapon freedom is running rampant throughout the country
- 11. Also opposed to ANY weapons on campus, concealed or open carry!
- 12. But...should be allowed when person works for campus police or protective government agency in protecting those who are on campus.
- 13. I will retire immediately and never return
- 14. College-age humans are known for sometimes making bad choices. When bad decisions are made, adding a gun to the equation can become deadly for innocent bystanders. I see no reason to allow concealed weapons on campus and I fear for the ultimate safety of students on campus.
- 15. the fewer guns, the better
- 16. The available research shows that it is NOT effective to arm so-called protectors (faculty, staff) In educational settings. To the contrary, this brings greater danger of mishaps. Please be guided by the research, not politics!
- 17. Guns on campus is a terrible idea!
- 18. I'm opposed to allowing any weapons on campus except licensed officers of the law.
- 19. If no one has them, no one needs them.
- 20. Horrible idea!!! I was a Health Care Provider in Health Services at ASU. SOOOO many students have mental health issues. Guns in people with mental health issues are an established potential disaster! Why would anyone consider this a good thing??? It's insane! How would

- residential life handle it when a roommate has a gun... is that fair to the other roommate? What a nightmare that would be for residential life to manage...
- 21. Guns are not an answer to anything. The campus needs to be free from the threat that concealed weapons can bring.
- 22. If concealed guns were allowed on University campuses in Arizona, I would make sure none of my grandchildren attend those schools and would discourage any of my relatives from sending their children and grandchildren to Arizona schools. Concealed guns would increase danger on campus. Guns and schools don't mix. Keep guns off our campuses!
- 23. Guns on campus is a recipe for disaster. We should oppose this strongly!
- 24. The security we now have on campus would be severely compromised with firearms being encouraged.
- 25. Criminals will have concealed guns. Faculty must be able to defend themselves while awaiting police.
- 26. Frightening to be standing in front of large lecture room with gun in there
- 27. Increasing the presence of lethal weapons on campus increases risk. Faculty have been killed in classrooms (U of A) by guns. Please stop this escalation of lethality.
- 28. This is, unfortunately, a zombie bill: it will probably be defeated this year, but we will see it again in some form. This isn't the first time this has been proposed.
- 29. I am a Professor Emerata from Arizona State University and I find the thught of concealed weapons on campus absolutely frightening. There are already too many weapons in the hands of people who do not use them responsibly. Increasing the numbers of weapons in any public area increases the liklihood of injury to innocent people. I can not imagine standing in front of a classroom, knowing there might be concealed weapons within the student group assembled. Please vote against allowing concealed weapons on all Arizona State Universities.
- 30. Concealed weapons on campus is likely to lead to preventable bloodshed on campuses.

- 31. I think it is appalling that carry, open or not, is permitted anywhere, but especially object to it on campus.
- 32. These are very stressful times for all of us now and allowing guns on campus would be the worst possible solution to any problem. Many people are experiencing various levels of mental issues these days and by putting a loaded gun in that person's hand is just fueling the fire! Anyway, why would anyone feel the need to bring a concealed loaded gun on campus anyway? We are an institution of learning, not a location for target practice!
- 33. I worked in the personal counseling mental health area of ASU. Some of the students which are seen are struggling with various degrees of mental health and not fully capable of taking care of themselves and handling their busy academic and work schedules let alone having easy access to guns. Approving such a bill would allow them to possibility use on a bad mental health day in the wrong circumstance in which several students, staff and faculty etc. could suffer horrid results. BAD IDEA!!!!
- 34. Guns on campus would be disastrous!
- 35. Guns are not for a learning environment and always unsafe if not handled appropriately.
- 36. This would be a HUGE mistake to allow guns on campus. I worked at ASU for 12 years. Do not allow this to happen!!!
- 37. This is not a good idea, more people will be dead if guns are allowed on campus.
- 38. This isn't the wild west. There is no need for concealed nor unconcealed weapons on campus except for ASU police officers. The idea that this is even being considered is ludicrous! Further, having weapons on campus will only promote INTIMIDATION and ENHANCED violence on campus. Just because we could doesn't mean we should. ASU will no longer be considered a safe work and school environment if concealed guns of any kind are allowed on campus.
- 39. No way, no how.

- 40. Guns are designed to kill. I have spent my entire work life 42 years on college/university campuses, as faculty member, department chair, division director. Students are great but still growing, maturing, and on their way to adulthood. Not there yet! NO GUNS!
- 41. Why in the world is such a thing even being considered!!
- 42. I have been opposed to allowing guns on campus for a long time. Allowing concealed weapons in campus is just compounding the problems with the initial question of guns/weapons on campus. There is a mistaken notion that having a gun in one's possession anytime is an expression of the 2nd Amendment. It is not. It is the expression of lawlessness and of an uncivilized society.
- 43. My understanding is more weapons available increases use of them
- 44. Please! Guns escalate confrontations. Guns are not tools for de-escalation. Allowing weapons on campus makes the campus exponentially more unsafe.
- 45. I have been in front of a classroom when a disagreement escalated. I am glad that it did not result in violence or the deployment of a concealed weapon. I am unsure why concealed weapons are required?
- 46. There is no need for weapons in an educational institution.
- 47. There is NO reason for ever allowing anyone other than officers of police. They are trained in the correct safe enforcement of law which means that they decide might use of a weapon. No other person would possibly be appropriately trained. Shooting a gun concealed or revealed would be terribly dangerous for everyone.
- 48. But I do believe we should be allowed to lock our weapon (if we have one) in our vehicle.
- 49. Having helped a graduate student (years ago) that became depressed and then threatened his professor/advisor with a gun and subsequently committed suicide on campus, I have first hand knowledge of what can occur when guns are on campus. Even without that incident, I am adamantly opposed to guns on campus.

- 50. Concealed weapons on campus will increase the chances of harm rather than increase protection.
- 51. If I were not already retired, I would quit if guns were to be allowed on campus via concealed carry rules.
- 52. The possibility of armed students in their classroom is the last thing professors and students need to worry about.
- 53. As a former hunter and long time gun owner as well as a retired professor, the only reason I can imagine for someone to bring concealed weapons on campus is to commit actions intended to injure others. For safety purposes, we prohibit racing cars or motor cycles on campus and even restrict bicycles and skateboards for many heavily used areas. Why in heavens name should we allow concealed firearms?
- 54. I spent 24 years at ASU, retired from ASU Police Dept. From time to time a responsible student came to the department to check their gun in lock up till they left campus. But they had to carry the gun on campus to get to us. I have no doubt there are some folks who carry a gun, even though it is not allowed. A man retrieving his gun from our lock up asked me if I minded if he loaded the gun and chambered a round. I told him I did mind and that he can do that at his car as he leaves campus. There are enough concerning gathering on campus, protests, and anti-protests. It will not surprise me in the least when verbal disagreements turn into fatal violence. We fail to learn from history when we don't remember what happened on the WV campus years ago when one student with a gun opened fire on unsuspecting students and faculty. Report on Finance Committee Meeting on 2/21/2021

Finance Committee Meeting on 2/21/2021

Present: Barry Bruns, Carolyn Minner, Gary Kleemann, and Barry McNeill

Topic: What to do if anything with the excess funds in the Operations Account

Background

At the September Board meeting the Finance Committee presented the Financial Health of the Association report (see table below). The report showed ASURA was financially healthy, and it pointed out there was a sizable Excess Funds in Operations, significantly more than the previous years.

The Finance Committee meet with Jerry Snyder on September 27 to discuss the required annual review of expenses. The report to the Board was delivered during the October Board meeting. The review of expenses showed things were fine and included several comments one of which addressed the Excess funds in Operations. The main thrust of the comments about the Excess was that the Finance Committee should meet to discuss what to do if anything with the Excess. The final comment was:

While either long-term or short-term options are possible, until getting COVID better under control and effectively behind us, short-term or one time options seem a more reasonable approach to consider.

Meeting Discussion

Barry presented an Excel table that made some projections about the future size of the Excess. The table showed that the Excess stayed at or close to \$30,000 for the next 3 years, about \$10,000 over historic levels. It was clear that taking \$10,000 out of Operations was not going have long term negative impacts.

So, the question became: What is the best use of these Excess funds? There were several options

- 1. Purchase a large item that ASURA would like to have but felt it was too expensive
- 2. Put the money in the Scholarship Endowment fund
- 3. Increase the size of the Scholarship
- 4. Increase the size of the Scholarship but split it into two scholarships

These four options were discussed with the following conclusions

- 1. No one on the committee was aware of any large item and this idea was set aside.
- 2. There are long term benefits from increasing the Scholarship endowment, including increasing the annual payout from earrings to the Scholarship spending account. The greater the amount in the spending account the less has to come out of Operations to pay for the Scholarship.
- 3. Increasing the size of the scholarship had some appeal, especially with the imposition of various fees above and beyond tuition. This could be a long term commitment or possibly spread out over several year. At the present time a long-term committeeman did not seem prudent. Spreading it over five years by increasing the scholarship amount by \$2,000 per year is certainly feasible.
- 4. There was no support for splitting the scholarship. Sue Blumer and Joy Shearman, long time Scholarship Chairs have expressed no desire to split the money into two pots.

Recommendation

The committee recommends Option 2, building up the endowment. This has long term benefits that are not possible if the excess is used to increase the scholarship for a few years.
