University Senate Dashboard October 2022 edition

A message from University Senate President Penny Ann Dolin

Since our last Senate meeting, I have been thinking about our future college students — who is going and who is not. John Arnold, executive director of the Arizona Board of Regents, gave an excellent presentation at our Senate meeting on Oct. 3, 2022, and some of what was covered was about college enrollment in Arizona.

Some of the facts I heard about the numbers of students going to college after high school were quite alarming.

According to ABOR, "Arizona continues to lag the national average in the number of residents with a bachelor's degree."

Although we are close to the national average in completion of high school (87% of Arizonans have obtained at least a high school diploma — nationally, that number sits at 89%), according to the U.S. Census Bureau, only 30% of Arizonans have obtained at least a bachelor's degree.

Before you think it is mainly an Arizona problem, "there are more than one million fewer students currently enrolled in college (as of July 2022) than in early 2020 before the COVID-19 pandemic began sweeping the nation," according to OH Predictive Insights.

Why should we be so concerned?

Well, the median college graduate makes a total of \$2.8 million throughout their career, compared to \$1.6 million (a **70% difference**) earned by their high school graduate peers, according to a 2021 study by Georgetown University's McCourt School of Public Policy. According to an article in **Foreign Affairs** magazine, it is beyond an educational attainment issue. It impinges on our national security. "The erosion of the United States' educational edge will eventually weaken the country's global reach. With a less highly educated workforce than it could or should have, the United States will have less economic, political, and military heft with which to defend its interests and uphold the economic and security architecture that has defined the postwar order."

But regarding the benefit to society, citizens lacking in critical inquiry skills and the ability to understand many of the advancements and trajectories of our society face a more daunting path to being productive members of society.

This is a hard problem to tackle, but I challenge all of us to try to do something. If each of us in our communities, in our local school districts, can speak with at least one class that is focused on the discipline we teach, reach out to one high school teacher to bring their students to visit an ASU class, perhaps we can move the dial. Never forget that students are our business — we need to make getting a college degree a valued goal for all high school seniors in Arizona.
